

Contest Rules & Regulations - OFFICIAL RULES

Eligibility

The **VISTEK "WHAT A TRIP" CANON TRAVEL CONTEST** is open to Canadian residents only. Unfortunately, this contest is not open to the residents of the province of Quebec. INDIVIDUALS MUST BE 18 YEARS OF AGE or older to be able to participate in the contest and claim any of the prizes. EMPLOYEES OF VISTEK and members of their respective families are ineligible to participate in the contest. EMPLOYEES OF ANY SPONSOR or agency involved with the contest are ineligible to participate in the contest, as are members of their respective families.

No purchase necessary to enter or win. A purchase will not increase your chance of winning.

There are two ways to enter:

To be eligible for the drawing in any particular during the Contest Period, entrant must complete entry before Thursday, June 30, 2016 11:59 PM Eastern Standard Time (EST). Upon submission of your entry online, you will be automatically entered in the contest, subject to the qualifications in the outlined in the eligibility criteria.

Limit one (1) entry per person regardless of whether the entry is made in store or online. All entries from individuals found to have entered more than once will be void. In the event of a dispute over the identity of a potential winner, the potential winner may be required to provide identification sufficient to show that he/she is the person identified on the entry submission and is otherwise eligible to win.
